- A. If you lend your business name to others, you may be subject to the following disadvantages as taxes related to the concerned business are imposed on you.
  - (1) You may need to pay more national pension and health insurance premium as greater amount of income than your actual income is reported in your name to the tax office.
  - (2) If the person who borrows your name fails to pay taxes, you may become tax delinquent and be subject to various disadvantages such as seizure and public auctioning of your assets, notification of the tax delinquency records to financial institutions and prohibition of overseas travel.
- B. If it is found that your business is registered and run in other's name, you will be subject to the following disadvantages:
  - (1) According to Article 22 (1) 2 of the Value Added Tax Law, you should pay your tax payable plus 1/100 of value of supply for a period between your declared date of business commencement and preliminary return period (or taxable period, if the preliminary return period expires) during which the business is actually commenced.
  - (2) According to Article 21 (2) 9 of the Resident Registration Act, if you illegally use other person's resident registration number, you will be sentenced to 3 years or less in prison or fined for up to 10 million won.
- C. If tax invoices or invoices are issued or received when there is no actual transaction, the company, its representative or related persons may be subject to 3 years or less in prison, or fine that does not exceed twice the value of supply and VAT, according to the Article 11 (2) of Tax Evasion Punishment Law.
- D. You must apply for credit card merchant membership and provide credit card service in the name of the business owner. If you provide the credit card service for a non-business purpose, you may be subject to 3 years or less in prison or fine that does not exceed 20 million won according to Article 70 (2) of the Specialized Credit Financial Business Act.
